Leadership Corner—Pam Forsha

Gender shouldn't be a factor in whether or not a person can be a great leader – a person's leadership abilities should depend on their individual strengths and personality traits. Well sure, everyone knows that, right? Unfortunately, while the world is evolving,



women are still lagging behind when it comes to leadership roles in business. According to a recent Forbes article, today, only 26 women are in CEO roles at Fortune 500 companies, making up 5.2% of the female population, and the stats stay virtually the same for women CEOs of Fortune 1000 companies at 5.4%, showing that there is little movement of women making up these high-ranking positions as company leaders. One statistic states that it will take 108 years to close the gender gap. In a nutshell, women's progress in the workplace is stalling out.

One of the biggest challenges women are currently facing is equality in the workplace. The economic gender gap is moving too slowly despite the attention being paid to pay equity and gender bias. To heighten awareness, the campaign theme of this year's International Women's Day was 'Balance for Better' - Better the balance, better the world. The campaign theme provided a unified global direction and called for collective action and shared responsibility all year long.

With women still pushing to reach the top, they are faced with a range of challenges that many of their male counterparts don't have an understanding of. It is these issues that are preventing many women from achieving their goal of becoming leaders and diminishing their ability to get ahead in business. Take, for example, the unpaid burdens that women shoulder like child care or the 'motherhood penalty' as identified by some, the lack of division of household chores, lower access to venture capital funding for women entrepreneurs, less pay for women's sports teams, and gendered pricing.

While achievements for diverse representation in top leadership roles should be celebrated, this in no way ensures women's continued advancement across a variety of domains at work and beyond. AAUW is an advocate for civil rights, supports education, and enforces Title IX while promoting gender fairness, equity, and diversity. Remain engaged with AAUW during our 'summer break' and continue the fight for equality. See you in the Fall!

Gender Pay Gap Forum Conducted at the University of Washington - Robin Hendricks

On April 17 the Women's Center at the University of Washington and the Seattle branch of the AAUW hosted a forum in Kane Hall on the university campus that provided information on the gender pay gap. The forum presented causes and consequences of the issue as well as information on individual rights, what individuals can do to further change, and legislative actions. Marilyn Watkins, Ph.D., Policy Director and Gabriela Quintana, Advocacy Director from the Economic Opportunity Institute (EOI) presented the history of the pay gap, what is currently happening, and ways individuals can make a difference. Dr. Sutapa Basu, Ph.D., Executive Director, UW Women's Center moderated. Fiona Goodchild gave an overview of the work and mission of AAUW. The event was attended by about 50 young women, under graduates and graduate students. Included in those attending was a graduate student who had received a scholarship from an AAUW branch while she was an undergraduate. She was delighted to see the AAUW was a co-host.

April Board Meeting Summary—Marianne North

The Branch paid most expenses for five Branch delegates to attend AAUW Washington State Convention in Bellingham April 12-13. We will again sponsor the TABLA basketball and Branch volunteers are needed for an event in July. AAUW has a Branding Guidelines document, <u>AAUW-Brand-Guidelines</u> (https://www.aauw.org/files/2013/02/AAUW-Brand-Guidelines.pdf). Our Branch's total assets have now recovered from the market drop in December. The Finance Committee is reviewing our investment options as well as considering increasing insurance coverage, because of our expanded publicity. We have 101 members. Those members renewing by July 1 may attend the September meeting for free. A revised Policy 10 governing the Program Committee was approved and is posted on our website Under Policies & Procedures (https://seattle-wa.aauw.net/policies-procedures/). The final Board Meeting of the AAUW fiscal year will be Monday, May 13th at 6:30 pm, an end of year potluck with incoming officers.

Legislative Update and Special Message from the Public Policy Chair Gay Armsden

<u>WA Legislature.</u> There is a lot of good news out of the legislative session (last day: April 28th). All but one of the bills that were detailed in March's *Catalyst*, have passed both houses. They are:

ESHB 1696 would prohibit employers from asking job applicants about their wage or salary history. ESHB 1198, on the Governor's desk, would improve oversight and accountability in enforcement of Title IX and allow WA to respond to any changes in Title IX law making college students less safe on campus. HB 1149 clarifies that, to obtain a sexual assault protection order, a survivor is required only to allege and prove that she/he was sexually assaulted, but not prove that she/he has a "reasonable fear" about future assaults. The Reproductive Health Care for All Act (2SSB5602) seeks to enhance state law to ensure reproductive health care access for immigrant and transgender communities. Unfortunately, the House voted to amend it to exclude undocumented immigrants and the Senate didn't concur with the amended version, so its fate presumably will be negotiated. ESSB 5258 requires employers in service occupations that involve workers working in isolation to adopt a sexual harassment policy. SB 5649, signed by the Governor, will extend or remove (in the case of minors) statutes of limitations for sexual assault.

Special message. I will have been your branch Public Policy Chair for 2-1/2 years when my term is up in June. It's time to hand over the reins and engage another member in this very interesting position. This has been a bit of a challenging ride at times. First, fairly ignorant Me had to learn very quickly about the legislative process (who knew committees have such power?). Lobby Day intimidated me (turned out it's fun and fascinating). Then there was a new White House administration whose policy priorities often conflicted sharply with AAUW's and threatened hard-won rights and protections; yet it was obligatory to be nonpartisan in my reports to members (that's when "Speaking Truth to Power" became my refrain). Nevertheless, serving in this position was enriching and empowering: I am much more of an activist, more informed and more committed to trying to change things for the better through our laws - because that is really the best and possibly only way to achieve equity for women. And, it's been a pleasure! Keep up the great work with your activism. If you'd like to be considered for this position, contact Lynn Dissinger or Fiona Goodchild. Revised Bylaws to be Voted on at May Annual Meeting-Barbara Sando

The Board has identified four areas of change for the Seattle Branch Bylaws, and is recommending those changes to branch members for their approval by vote at the Annual Meeting on May 18th. The first revision is to update the succession plan for filling a vacancy in the office of President, such that any elected officer deemed suitable may be appointed, rather than only the VP Programs. The second and fourth revisions, respectively, reduce the minimum number of required board and branch meetings each year from eight to seven. These changes provide some latitude when meetings can't be held due to unforeseen circumstances (such as inclement weather or a power outage). The third revision addresses the requirement for financial reviews. Due to the complexity of the branch's financial assets, the board believes it is prudent to have an independent financial review conducted at least once every five years, and sooner if the board so determines. This bylaws change does not preclude the branch from conducting internal reviews of its finances as often as it sees fit. In addition to these changes, the revised bylaws also incorporate 'friendlier' titles for our elected officers, clarify (without changing) how our election process works, clarify the role of AAUW Washington State in the bylaws revision process, and correct a few typographical errors. These administrative changes do not require a vote, as they do not impact the way Seattle Branch operates. All of the revisions to the bylaws can be reviewed on our website, www.aauw-seattle.org.
